1. Eligibility Log and IMP Administrator log

As a reminder, any doctor who signs the patient eligibility form must be signed off on the eligibility log and on the delegation log (Task C only). They do not need to complete their GCP and we do not require their CV if this is their only role in the trial.

Bedside nurses who will be administering the IMP must first read through the required training and sign the IMP Administrator Training Log prior to giving any IMP. However, they do not need to be on the delegation log as this action is part of their usual duties.



2. PCR Diagnostic results

PCR diagnostic results are only reported to the site team via email. Please ensure you have all the correct email addresses on your sample shipping form. The lab team will only contact you via the phone if there is something urgent.

3. Documenting the consent discussion in the medical notes

It is vital that the consent conversation with the patient, NOK or ProLR are all clearly documented in the patient's medical records. It is good practice to include the full order of events, the name and version of consent form used.
