

AM10 – Protocol update

Amendment 10 has been circulated to sites, this includes updates to the protocol, version 2.0 includes the following changes:

- 1) Removal of the following exclusion criteria:
- Not expected to survive 90 days due to pre-existing chronic (end-stage) disease.
- Removing the wording:
 "A source of infection that will require a prolonged course of antibiotics, for greater than 21 days"

Updated to:

"Being treated for infective endocarditis, osteomyelitis, hepatic or cerebral abscess, tuberculosis."

- 2) Secondary Endpoint Update:
- The MOCA-Blind questionnaire at 6 months has been removed from the secondary endpoints, as agreed by the TMG.

Please can all sites familiarise themselves with the following changes in eligibility criteria. The updated Eligibility Form, and Eligibility training slides will be circulated later in the month.
