Amendment 10: Updated Eligibility and Protocol v2.0



Protocol v2.0 has now been implemented and all sites should now use v3.0 of the eligibility form which reflects the changes made to the eligibility criteria.

Checklist for implementing Amendment 10:

- 1) If you have not done so yet, please complete the online training to confirm you have read protocol v2.0, please send the confirmation email to septic@imperial.ac.uk.
- 2) Ask all clinicians who are currently delegated task C on the delegation log 'Confirming Eligibility' to retrain on the new updated version (v3.0) of the training slides

SepTiC Reminders:



1) Data Entry Deadline – 30th January 2026

- To prepare for the upcoming data extract, we kindly ask all sites to please enter any outstanding data into OpenClinica and **respond to all open queries**. This is crucial to ensure the completeness and accuracy of the dataset.

2) Sample Shipment

- All sample shipping forms must include the **patient ID** and **partial DOB** and any missing information may delay the PCR report being issued to your site.
- PCR reports are only sent to **email addresses** listed on the shipping form therefore you must ensure these details are correct. No text messages are issued.
- Do not send patient identifiable information to the SepTiC inbox or to the central lab

3) OpenClinica Scheduled update

- There is an OpenClinica scheduled update on Saturday 31st January 2026, between 2pm and 6pm (UK time). Please do attempt to randomise/enter any data during this period.
